To "increase the competitiveness and responsible behavior of Myanmar enterprises"


by providing matching grants to MSMEs for the implementation of projects that





#### **\*** RBF+ Objective

Promote inclusive growth of Agrifood MSMEs in local agricultural value chains, to enhance their economic resilience.

#### \* Mechanism

RBF+ will continue to use the "Matching Grant" mechanism.

#### **\*** Instruments of Support

- Up to 50% of the relevant project costs, with a maximum of MMK 400 million (Window 1), a maximum of MMK 200 million (Window 2), a maximum of up to MMK 35 million (Area 8-Window 3) and,
- Up to 100% of the relevant project costs, with a maximum of up to MMK 25 million (Area 9- Window 3) for each project.

#### **Direct Target Group**

MSMEs within the various Agricultural Value Chains that can benefit the farmers with productivity improvements, cost reduction or access to markets.



#### Role of Consultant/ Service Provider



Develop the project idea together with Business/MSME/Business Association to apply for RBF+'s

(9) Areas of support.



Develop a quality Project Proposal together with the Business/MSME/Business Association which includes a detailed implementation plan with clear timelines and milestones, identifies desired economic outcomes for MSMEs and producers, assesses potential environmental benefits, etc



Carry out the financial feasibility of the project idea which includes estimations of investment and expenses, calculations of potential revenue or cost reductions, an estimated payback period, and accurate cost allocation for the requested RBF+ support.



Identify two or more equipment suppliers to ensure that the business is proposing the right technology, service, and cost-effective equipment for the Business/MSME/Business Association to implement the project.

#### Role of Consultant/ Service Provider



Develop a quality Project Proposal together with the Business/MSME/Business Association which includes a detailed implementation plan of the project idea within the timeframe, identifying desired economic outcomes for MSMEs and producers, assessing potential environmental benefits, etc.



Demonstrate the strong connection between RBF+'s areas and Supported Equipment/Technical Assistance etc.



Collect baseline data required for establishing the Monitoring and Evaluation requirements of the project and assist the Business/MSME/Business Association in the pre-grant agreement meetings with the RBF+ Team, which is a prerequisite for signing the grant agreement.



Advice Business/MSME/Business Association about the documentation required at least seven days ahead of the required submission date.
